



# Student Textbook Rental Agreement

This Textbook Rental Program allows qualifying Indiana University of Pennsylvania students the opportunity to rent select textbooks for the duration of one semester.

The Rental Return Due Date for the [Spring 2019 Term](#) is [Monday, May 13, 2019](#).

By signing the textbook rental agreement at checkout in The Co-op Store, or by completing a rental transaction at [www.iupstore.com](http://www.iupstore.com), you agree to these rental terms and conditions, and you certify that you have read and understand the terms of this agreement:

1. I am at least 18 years of age. I am entering into this Textbook Rental Agreement (“Agreement”) of my own free will. I have never failed to return rental textbooks to The Co-op Store in the past.
2. I understand that all textbooks rented from The Co-op Store are the property of The Co-op Store. I agree that all identifying stickers, labels, etc. on rental books must remain intact and must not be removed, altered, or obliterated.
3. I understand and accept that at the end of the current semester, it is solely my responsibility to return the books I have rented under this program. I will return all rented books on or before the Rental Return Due Date, as stated above, in re-saleable condition, as outlined below. I agree that it is not the responsibility of The Co-op Store to remind me of the Rental Return Due Date.
4. **FAILURE TO RETURN:** I understand and agree that if I fail to return the rented textbook(s) to The Co-op Store before the close of store on or before the Rental Return Due Date, I will pay The Co-op Store a **Late Fee**. If I do not return the rented textbook(s) to The Co-op Store before the close of store on [Wednesday, May 15, 2019](#), I agree to pay The Co-op Store the **DIFFERENCE BETWEEN THE RENTAL FEE AND THE PURCHASE PRICE PLUS THE LATE FEE**. I understand and agree that if I fail to return the rented textbook(s) and fail to pay applicable fees as outlined above, The Co-op Store will petition Indiana University of Pennsylvania for payment and to place my student records on hold until the applicable fees are paid in full to The Co-op Store. Unresolved debts will be turned over to a Collections Agency.
5. **CONDITIONS UPON RETURN:** I understand and agree that highlighting and writing in rented textbooks is acceptable; however, I agree that rented textbooks must be returned in complete and saleable condition, at the discretion of the Co-op Store. This means that the spine, cover, and pages of the book are intact, there is no damage to the book, including water damage, and all component parts of the book are included at the time of return. I accept that I am fully responsible for any loss of, theft of or damage to any textbook I rent from The Co-op Store. I understand and agree that if I do not return a rented textbook by the Rental Return Due Date, I will not be eligible for The Co-op Store’s rental program in the future.
6. **REFUND:** I understand and agree that this rental fee is refundable only if the rental book is returned to The Co-op Store in complete and re-saleable condition by the close of store on or before [Tuesday, January 29, 2019](#). New package rentals will only be refunded if completely unopened.
7. I have read and I fully understand and agree to the terms and conditions as stated above.
